The manner in which delinquent taxes on mobile homes are collected has been changed by the enactment of the Mobile Home Local Services Tax **Failure to pay this tax will result in a penalty of \$25 per month not to exceed \$100. Penalty becomes effective the first day following the due date. Failure to pay these taxes may result in loss of mobile home.**

Your canceled check is your receipt. To request a receipt enclose a self addressed, stamped envelope with your payment. If paying in person, please bring this bill with you.

- 1. Assessment:** Owner of the mobile home as of January 1st of any year shall be liable for the tax that year.
- 2. Tax Payments:** No partial payments will be accepted. Non-payment of check by your bank voids any receipt. \$25.00 charge on all returned checks.
- 3. Registration:** Mobile home park owners shall register each mobile home entering such park. Homes not located in a park must be registered with your Assessor within 30 days of placement. Registration shall include Vehicle Identification number.
- 4. Exemption:** Senior citizens and disabled persons desiring their exemption should contact their assessor. City of Galesburg 309-342-1106; County 309-345-3664
- 5. Moving or Selling Mobile Homes:** A mobile home may not be moved without a moving permit signed by the County Treasurer. The Secretary of the State of Illinois will not transfer title of any mobile home to another person or party until all taxes have been certified paid by the County Treasurer.
